The staff of the CCS welcomes your questions or concerns related to canon law. They are available to assist you in understanding your situation and needs from a canonical perspective.

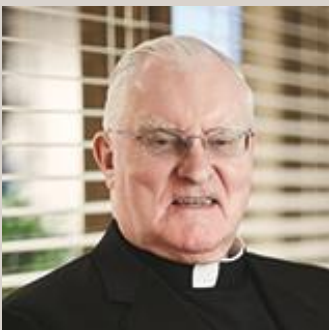

## The legacy of Fr. Morrissey, OMI

Fr. Morrissey served as Saint Paul University's Dean of Canon Law from 1972 to 1981 and helped to draft the text of the 1983 Code of Canon Law.

In addition to his academic work, Fr. Morrissey offered canonical consultations throughout the world to General Superiors and Dioceses. He believed that the rights and obligations of all should be known and respected, and that religious congregations and dioceses should have access to relevant canonical services.

Fr. Morrissey established the CCS in its current structure and functioning to ensure and provide for the continuation of his invaluable ministry for years to come.
